## 1. Approval of last meeting minutes

#### 2. Update on legal entity

Dave Reid presented to the group the two options for available to the group (as described in the meeting presentation)

- Option 1- Fiscal Sponsorship through the Parks People
- Option 2 Wisconsin Non-Profit Corporation, leading to 501 (3) ©

The group discussed the pros and cons and what is required and voted to go with Option 2 -Wisconsin Non-Profit.

Additional topic discussed was the Parks Amenities matching fund. Kim Morris shared the link with the group.

### 3. Review proposed bylaws

Mariiana Tzotcheva had prepared draft bylaws based on sample bylaws provide by the Parks department. Mariiana had highlighted sections where a decision is required to be made by the group.

In addition, the group will ask Laura from the Parks Department to share example bylaws where the group is a Wisconsin Non-Profit for comparison.

The following decisions were made:

- There will be a Nominating Committee
- The group that signs the bylaws will be the Board members until the first Annual Meeting
- Annual meeting of the Board will be in March 2017
- The Board will consist of 8-10 members.
- There will be no staggering
- The term of the Board members will be 3 years
- Removal will be by ¾ of the Board
- Meeting by Telephone is ok
- Action by written consent is ok
- Fiscal year will be December 31
- Marijana to update the bylaws with the agreed updates
- Next meeting, the group will review the updated bylaws and sign

In addition, Emily suggested changing the friends group name to "Cathedral Square Friends". The group agreed. Going forward the group will be referred as "Cathedral Square Friends" or CSF abbreviated.
